MOTION FOR LEAVE TO FILE AMICUS CURIAE BRIEF

Pursuant to Hawai`i Rules of Appellate Procedure 27 and 28(g), Public First Law Center (Movant or Public First) moves this Court for leave to appear as *amicus curiae* and to file a brief, in the form attached.

Movant is a Hawai'i non-profit focused on solutions that promote transparency and responsiveness in government. Public First regularly represents members of the public in litigation concerning the Uniform Information Practices Act (Modified), Hawai'i Revised Statutes (HRS) chapter 92F (UIPA).

Movant has a compelling interest in how this Court interprets the UIPA. As Petitioner Hawai`i Police Department, County of Hawai`i (HPD) seeks to do in this petition, government agencies frequently conflate the UIPA and various discovery or other disclosure standards in ways that obstruct public access. As this Court has held, the UIPA is not a confidentiality law. Thus, the UIPA has no bearing on Respondent Judge Peter Kubota's authority in the underlying dispute here, which is not related to a UIPA request.
