### MOTION FOR LEAVE TO FILE AMICUS CURIAE BRIEF

Pursuant to Hawai`i Rules of Appellate Procedure 27 and 28(g), Public First Law Center (Movant or Public First) moves this Court for leave to appear as *amicus curiae* and to file a brief, in the form attached.

Movant is a Hawai`i non-profit focused on solutions that promote transparency and responsiveness in government. Public First regularly represents members of the public in litigation concerning the Uniform Information Practices Act (Modified), Hawai`i Revised Statutes (HRS) chapter 92F (UIPA).

Movant has a compelling interest in how this Court interprets UIPA. As framed by the parties, this case concerns UIPA. But this is not a UIPA case at its core, and to interpret the privacy issues here based on UIPA would do a substantial injustice to the rights of the public to obtain information about how their government operates.

Movant seeks to offer a perspective from the intended beneficiaries of UIPA—the

general public — regarding causes of action for invasion of privacy and how those interact with UIPA, as interpreted by the Hawai`i Supreme Court in  $SHOPO\ v.\ City\ \mathcal{E}$  County of Honolulu.

Movant respectfully requests that the Court grant its motion for leave to file an *amicus curiae* brief.<sup>1</sup>
